#### **Election of a new Executive Committee**

The EC organizes an election of a new EC at the general meeting of the IOPTMH, in Madrid. The election procedure is based on our constitution (see constitution on the website www.icppmh.org).

The fifth General meeting 2016 has to vote for 4 persons in EC. The four elected and the fifth EC-members, divided the different position amongst themselves.

Some important informati-

on:

The candidate for membership of the EC must be endorsed by the respective National Mental Health subsections of their National Member Organization (art. 7.2 of the constitution).

The member country can propose more than one candidate. EC members may be from the same country, but there shall not be more than two Executive Committee members from any one Member country. To maintain diversity it is desirable with members from five different countries, and if possible from

two WCPT regions.

Before 31st of December member countries can nominate an EC member candidate by sending a letter of support signed by the national organization or subsection. This letter can be send to the President of the IOPTMH. All candidates send their short CV. This CV will be sent to the members.

In January 2016, all members will be informed about the names of the candidates together with the agenda for the fifth general meeting.

The chairman of the Madrid electi-

on committee is Rutger ljntema, secretary of the IOPTMH as chairman and two other persons who attend the Madrid conference (for the neutrality, coming from not member's countries). They are responsible for the whole election procedure during the Madrid conference. All election levels will be made by secret voting,

At the general meeting, all candidates will have five minutes and one ppt-slide to present him/her self

#### New Membership of the IOPTMH

Latvia applied the 20th of September 2015 for IOPTMH membership. The letter was signed by Liva Tiesnese, Ilze Rudzite.

The 30Th of October the Swiss Subgroup for physiotherapy in mental health signed all required forms for registration to IOPTMH. The applications are now send to the Swiss PT Association and afterwards Liv H. Skjaerven, vice-president of the IOPTMH and responsible for the new members.

In Australia 60 physiotherapists are interested in joining a mental health network. They hope to complete the paperwork to become a member in Madrid.

Also Greece, Mexico and other countries are preparing their application letter.
